### Reminders

- Please remember to email ALL questions, comments concerns via JIRA.

  Recovery Works has included an automatic message in email which directs all current providers back to JIRA.
  - We track numbers and assess needs based on volume of JIRA tickets.
- Recovery Works participants may not be asked to pay out of pocket for services (exclusion only for titrating from Recovery Residence services or insurance co-pays)





#### **Recovery Residences- Medication Assisted Treatment**

- Incentive for supporting residents who are utilizing MAT
  - Increase in Per Diem
  - MUST allow all three MAT options
  - MUST attend MAT training (DMHA contracted)

\*Discretionary Funds may be utilized for participants to purchase lockboxes to hold medication.

#### **Acceptance of MAT (ALL)**

- Level II-\$9 per day
- Level III -\$10 per day
- Level IV \$10 per day

#### No MAT Acceptance

- Level II-\$6 per day
- Level III -\$7 per day
- Level IV per day





#### Recovery Residences-Lifetime Cap

■ Increase lifetime cap to \$8,000







#### **Recovery Residences- Peer Recovery Support**

- \$250.00 is maximum allotment per month
- \$2,000.00 is the lifetime maximum. Services MUST be individual Peer. Providing services in a group setting not allowed.
- Providers MUST follow the guidelines for Peer Certifications listed in the Recovery Works P&P Manual
- To be billed weekly under Recovery Residence as a separate encounter.
- The \$2,000.00 is in addition to the \$8,000.00 Recovery Residence maximum.
- Recovery Residences must follow the guidelines listed in the manual under peer recovery services. This includes certification standards of a Peer Recovery Coach.



## Legislative Updates

#### Additions to IC 12-23-19 (Recovery Works)

- Competency Restoration Services
- Recovery Community Organizations
- Collection of demographics





#### **Competency Restoration**

- Alternative to State Hospital setting
- Reduce forensic backlog





#### **Recovery Community Organizations**

Recovery Works has begun the process of partnering with RCO's to allot for Peer Service Support billing.

- A Recovery Community Organization (RCO) is an independent, non-profit organization led and governed by representatives of local communities of recovery.
- RCO's will obtain certification through an outside vendor contracted by DMHA
- RCO's will be able to bill for Peer Recovery Services





Referral Process-In an effort to collect the required legislative data and ensure equity in referral distribution, the referral process for Recovery Works will change.

Criminal Justice Partners identifies Participant and sends necessary information to Regional Liaison.

Regional Liaison contacts the participant to determine needs and collect necessary data. RL completes referral and sends to necessary providers.

Providers complete intake/assessment process.

Monthly progress notes/communication are sent from DSP's to CJP's.





#### **Referral Process: Recovery Liaisons**

Recovery Works has partnered with an independent agency to reorganize the way referrals are distributed. Target date of implementation January 1, 2022.

- The state will have Regional Liaisons who will distribute Recovery Works referrals
- Criminal Justice partners will still identify the participant and forward information and CJ documentation to the liaison
- Regional Liaisons are responsible for identifying the total needs of the participant and distributing referrals to the necessary providers
- Referrals will be distributed according to participant choice and/or provider availability.
- Priority to ensure there is little to no time delay to services





#### Crisis funding

- Funding for the population of RW consumers who have maxed out their funds but are in mental health crisis.
  - Specific providers will be selected to receive reimbursement for crisis funding
- Funding for individuals who have prior justice involved history who do not

have a current open case





- Resources for post-justice involved persons in recovery
  - Supportive services through community recovery support agencies including discretionary funding for utilities, security deposits, etc.
    - Not necessarily in crisis.









#### Emergency Rooms

• Emergency Medical Professionals making referrals.

\*IF your agency has mental health staff in emergency rooms, PLEASE send JIRA ticket notifying us of this with details of position, number of staff, etc. We want to establish a stronger understanding of triage supports for those in mental health crisis.







- Diversity, Equity and Inclusion Training
  - Will be added to list of required trainings (Motivational Interviewing, Justice-Involved Persons, etc)
  - Trainings will be provided through DMHA by contracted agency.







Recovery Works will send information via email for providers to complete. It is VERY important this information is returned by the deadline, as this will assist the Regional Liaisons in distributing referrals.
